### MEMBERSHIP TERMS

- 1) The Chicago Match Race Center, LLC (CMRC) season commences mid-April and ends early October. Skipper and crew will have the seasonal use of one CMRC keelboat for practice and racing. In return, Member agrees to abide by CMRC's Member Rules & Regulation and acknowledges receipt of same. CMRC's Director may, in his/her sole discretion, terminate member's license for violation of CMRC's Rules & Regulations. Membership fees are forfeited upon termination of this license.
- 2) Membership is contingent upon acceptance by CMRC. Membership may also require sailing resume and interview.
- 3) *License:* CMRC grants the skipper the right to the seasonal use of one CMRC keelboat each Tuesday and Friday evening, from 5:30pm CT until dusk, strictly for practice and racing and only in the designated waters at the north end of Belmont Harbor. The boat may not be used by anyone other than the skipper named in this agreement and his/her designated crew. All of whom must be CMRC members. This is a revocable license as set forth in paragraph one (1) above.
- 4) *Security Deposit:* Skipper shall return the keelboat in as good condition, ordinary wear and tear excepted, as when received. Skipper's \$2500 security deposit applies to any physical damage to the keelboat, (including its rigging, sails, fittings, and all other equipment) that occurs while under Skipper's command and control. Skipper's liability for physical damage to the keelboat shall be limited to \$2500. Any unused portion of the security deposit shall be refunded to Skipper within 14 days after the end of the season.
- 5) *Release, Waiver, Hold Harmless and Indemnification Agreement:* Member hereby acknowledges that he/she has carefully read the attached Release, Waiver, Hold Harmless and Indemnification Agreement, the terms of which are fully incorporated herein by reference. \_\_\_\_\_ (Initials)
